SUPPLEMENTAL DECLARATION OF SERVICE

I, David C. Skinner, being duly sworn according to law, depose and certifies as follows:

1. I am a Senior Consultant at Kurtzman Carson Consultants LLC. ("KCC") My business address is 8475 Western Way, Suite 110, Jacksonville, FL 32257. My direct telephone number is 904-807-3031.
2. I submit this supplemental declaration in connection with the class action notice administration proceedings related to *Buus v. Wamu Pension Plan et al.*, Civil Action No. 07-903 (W.D. Wa.) at the request of Lead Counsel.¹
3. This supplemental declaration is based upon my personal knowledge and upon information provided by my associates and staff.

NOTICE EFFECTUATION

4. As of the date of this supplemental declaration, 741 of the 18,642 Notices mailed have been returned by the USPS to KCC as undeliverable as addressed (UAA) and 76 as forward order expired (FOE); of those 741 returned UAA, KCC used a locator service to obtain updated addresses for 728 and mailed Notices to these updated addresses; of those 728 re-mailed notices 169 were returned as UAA; of those 76 returned FOE, the USPS provided updated addresses and

KCC resent Notices to the updated addresses. All FOE notices mailed that have been returned have been resent to forwarding addresses.

CALL CENTER

5. From September 23, 2010, through the date of this supplemental declaration, KCC has received 363 telephone calls and 7 voicemail messages.

WEBSITES

6. From September 23, 2010, through the date of this supplemental declaration, KCC provided the case-related documents available for download by potential Settlement Class members: (1) the Notice, which has been downloaded 34 times; (2) the Amended Complaint, which has been downloaded 26 times; (3) Plaintiffs' Motion for Preliminary Approval of Class Action Settlement, Approving Form and Manner of Class Notice, and Setting Date for Hearing on Final Approval of Settlement, which has been downloaded 23 times; (4) Memorandum in Support of Plaintiff's Motion for Preliminary Approval of Proposed Settlement, Approval of Notice Plan, and Setting of Fairness Hearing (the "Memorandum in Support"), which has been downloaded 5 times; and (5) the Preliminary Approval Order, which has been downloaded 7 times to date. All statistics were compiled on October 20, 2010.

The Class Notice, the Settlement Agreement, Plaintiffs' Motion for Attorney Fees and supporting papers were posted on several internet websites identified in the Class Notice.
