1 The parties have conditionally agreed to a proposed settlement of this legal action.  
2 It appears to the Court that the attached Settlement Agreement of Class Action Claims is  
3 the result of arms-length negotiations between the parties, represented by their respective  
4 experienced counsel. After reviewing the terms of the proposed Settlement Agreement, in  
5 the context of this action and the controlling legal authority, the Court finds that the  
6 proposed Settlement Agreement is fair, reasonable, and adequate, and is consistent with  
7 relevant state law.

8 IT IS THEREFORE ORDERED THAT the Settlement Agreement is APPROVED,  
9 and this Order shall be deemed the "Final Judgment" for purposes of Section VII.A. of the  
10 Settlement Agreement regarding the effective date of that Agreement.

11 IT IS FURTHER ORDERED THAT the late claims of Class Members described in  
12 Section II of the parties' Joint Motion For Final Approval of Settlement Claims and  
13 Approval of Late Claims are approved and those Class Members may participate in the  
14 Settlement. The distribution set forth in Exhibit A attached to this Order is therefore  
15 approved.






